1. **Axiom Traders** will provide the Account Holder the ‘HFT Trading System’ to trade on his account opened with the Third Party Broker: _____ account #: _____ Username: _____ (password will be mailed to the following email address of **Axiom Traders** [Axiom HFT-LTS Client's Server Agreement](#) if applicable.
2. **Axiom Traders** will provide the Account Holder the ‘HFT Trading System’ and will configure the Account Holder’s account with Third Party Broker’s client terminal providing the gateway with different Liquidity Providers, Market Makers, Banks and Exchanges with the Client’s API (Application Programming Interface) and connectivity with the ‘Feed Manager Server’ and the ‘Back End Systems’.
3. **Axiom Traders** is authorized to follow the instructions of the aforesaid Attorney in every respect concerning the undersigned Account Holder’s account with Third Party Broker, except that said Attorney is not authorized to withdraw funds either in the name of Account Holder, Introducing Broker or otherwise. The Attorney shall be legally authorized to represent the Account Holder regarding any and all present and future dealings with the Third Party Broker in particular with respect to all assets deposited in the Account Holder’s account(s) with the Third Party Broker, and to execute orders on the client’s trading terminal provided by the Third Party Broker to the Account Holder, to buy and sell spot and foreign exchange for the Account Holder’s account(s), through the HFT Trading System configured to the Account Holder’s account. The Account Holder releases **Axiom Traders** and Third Party Broker from any responsibility whatsoever for all acts or omissions on the part of the Attorney’s instructions.
4. **The Attorney** shall be authorized to accept, check and approve statements of account and other correspondence intended for the Account Holder. Additionally the Account Holder authorizes the Attorney



to substitute himself by hiring a Third Party Broker to act in his stead and provide the Account Holder to trade through the client’s terminal licensed by MetaQuotes Software (MT4 or MT5 respectively).

5. **The Account Holder** will open his online trading account with the Third Party Broker himself following the Third Party Broker account opening procedures. The Account Holder after opening the online trading account will provide to the Attorney the Username, Password and all other Log-in instructions via email at [Axiom HFT-LTS Client's Server Agreement](#)
6. **The Account Holder** will deposit the funds with the Third Party Broker as per the instructions of Third Party Broker, the policies for the withdrawal and deposits will be followed as per decided by the Account Holder and Third Party Broker themselves. Attorney will have no authority for the deposits and withdrawals from or to the Account Holder’s account in any circumstances.
7. **This Power of Attorney** shall remain valid towards **Axiom Traders Limited** until revoked in written by the Account Holder. This Power of Attorney shall not expire upon the death, bankruptcy or the loss of legal capacity of the Account Holder or the Attorney.
8. **The Account Holder** signing this power of attorney should be aware that a difference between the exchange rate offered to the customer and that which Third Party Broker can obtain, may be accepted by the Attorney as a premium if agreed and decided by the Third Party Broker and the Attorney.
9. **The Third Party Broker** will provide the Account Holder with a confirmation of every trade made on his account(s) and a profit and loss statement showing the financial results of each transaction. In lieu of sending a trade confirmation and equity run via email, Third Party Broker will provide the Account Holder with access to his account via internet using an online log-in. Since the Account Holder has been provided with the Attorney’s developed ‘HFT Trading System’ to execute trades on Account Holder’s behalf, the Account Holder will be unable to trade on his account as long as the power of attorney remains in force. If in any case the Account Holder trades on his account by himself in such the Account Holder will be solely responsible for all losses/profits made by his personal trades.

Diagrammatic Representation of FIX System

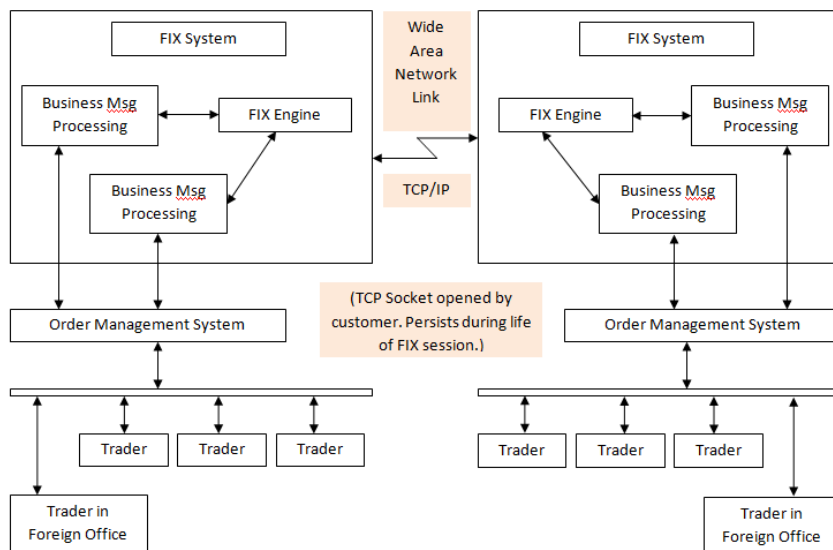
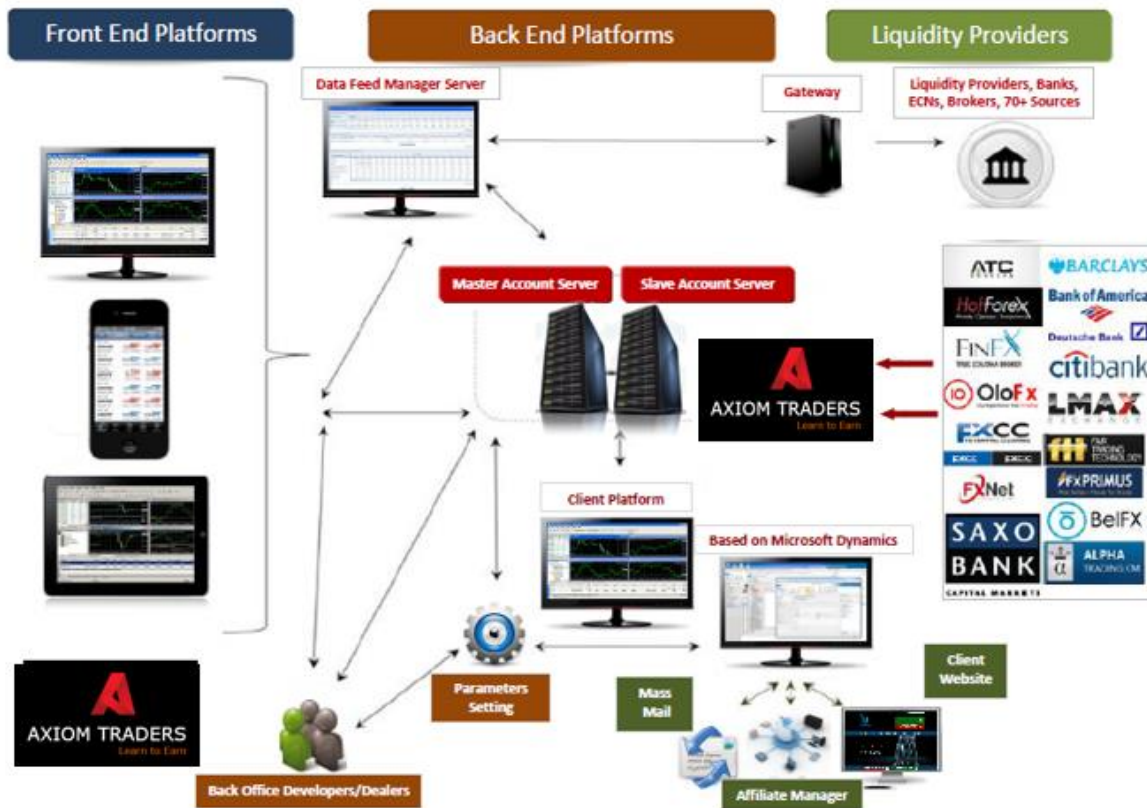




Diagram of How our HFT-Laser Trading System Works
